The Referee & Coaches Seminar in Riga will cover a number of topics.

- Briefing & Clarification of Rules
- Scenario's
- Examinations
- Seminars: Kumite & Kata practical for Referees and Coaches (in karategi).

The WKC Rules of Karate Tournament are by far the best in the world. They have proven to be so at the highest level and have stood the test of time. To fully utilise them we need strong Referee's and strong Judges. I am pleased to say WKC has today many top quality officials and it is committed to producing many more.

Many Referee qualifications will have now expired, please check your licence books or the WKC website under Technical/Referees. For new officials and for those seeking higher/retain qualifications, please be <u>fully</u> conversant with the Rule Book and be in a position to successfully complete the written examination (Judges must attain 80% pass mark, Referee's and above, 90%). With the exception of a small number of questions, all questions on the Examination paper are on the WKC Website as are all the Referee Signals and Commands. Amongst others, all officials must know Part B: Kumite Contest Rules – Shobu Sanbon, Articles 6,7, 8 & 9.

All officials must possess the complete Referee Uniform (please see WKC Rule Book). Only black tatami/gym shoes will be permitted on the Tatami. Please advise the WKC Office of any requirements you have well ahead of the Tournament date.

To become a Kumite Judge or Referee, candidates must possess the complete Referee Uniform and pass the written examination, the Kumite Judging Assessment and the Tournament Kumite Judging Assessment.

To become a Kata Judge, candidates must possess the complete Referee Uniform and complete the Kata Assessment Examination, performing a selection of kata's to a satisfactory level in front of the Kata Assessment Panel (in karate-gi), successfully complete the Kata Judging Assessment and the Tournament Kata Judging Assessment. Kata Judges will be asked to demonstrate and pay particular attentions to stances and form used within the different styles.

Referee's whose qualifications have <u>not</u> expired must attend the briefing but do not need to attend the Seminar, they may however be asked to assist at it. Existing judges are encouraged to progress to Referee. Coaches are encouraged to take the Referee Examination for their own personal private development.

Reminder: Referee/Judge qualification terms are as follows:

Judge: 1 year, Referee: 2 years, Senior Referee: 3 years, Senior Executive Referee: 4 years. You cannot be a Senior or Senior Executive Referee without a Kata Judge Qualification.
